After a discussion regarding questions and concerns about the "free use policy" by volunteers, the following motion was passed:

Chilson/Brown motion passed that a volunteer may be granted by the board a free use of the rec center. The free use will be decided by the board on a case-by-case basis as long as they have provided their criminal background and child abuse clearances and have actively volunteered for at least one season.

Brown/Harnish motion passed to hold a free clothing giveaway on April 30 from 9:00 a.m. to 1:00 p.m.

After a discussion regarding rentals being scheduled and then the people not showing up without cancelling, and after some discussion about the hardship of keeping track of and getting down payments as many rentals are scheduled very close to the day of the rental, the following motion was passed:
